Morningside Monthly Meeting of the Religious Society of Friends (or Quakers) meet every First Day or Sunday on the 12th floor of the Tower. Our meeting began in the 1950s and we first met here at Riverside Church before moving to the Columbia University campus. We came back to Riverside nine years ago. We would like to take this opportunity to express our gratitude to Riverside Church for hosting our Meeting among this spiritually diverse and vibrant religious community.

Quakers believe that each of us has God within and our Meetings for Worship are held in expectant silence. We aspire daily to live in accordance with our Testimonies. Because "that of God" is always with us, we are called to the Light every day and in all of our actions. This is the Testimony of Integrity. Because all people have this access to the divine, we are led in the Testimony of Equality. The presence of the Light in all people calls us to the Testimony of Peace. Since outward material display distracts us from living in clearness in the Light within, we seek Simplicity.

We wait on the Light within to speak through us in messages out of our silent Worship. As our Meeting upstairs is listening in this silence, we would like you to join us in waiting on God.

Meeting for Worship with a Concern for Business October 3, 2010

Meeting opens at 1:12pm with a period of waiting worship. Out of the silence Clerk Sally Campbell reads a quotation from New York Yearly Meeting Faith and Practice

The Quaker business procedure rests on faith that God is giving a measure of Light to everyone. It follows that people may come to know God's leading through others' experience as well as their own. One of the deeply spiritual experiences of Quakerism comes when a meeting for business responds to the essential goodness and truth in a well-proposed concern with an awesome silence and then messages of approval.

There should be a willingness to speak or to be silent as led. Friends should rely on the power of the spirit of truth and seek to keep their speech simple and straightforward. If the meeting is to reach a group decision, participants need considerable personal discipline and an allowance for humble or tentative conclusions.
